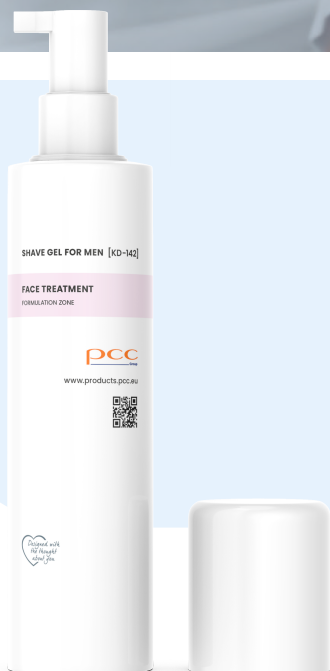

## Procedure:

1. Combineer de ingrediënten uit fase A. Voeg langzaam Carbomeer toe aan het water terwijl je mengt. Meng tot uniform. Voeg andere fase A-componenten toe. Homogeniseren met 2000-3000 RPM, 90-120 sec.
2. Voeg tijdens het mengen natriumhydroxide toe. Meng tot uniform.
3. Voeg tijdens het mixen fase C-ingredienten toe. Homogeniseren met 2000-3000 RPM, 120-180 sec.
