Procedure:

1. 별도의 용기에 상 A, B 및 C의 성분을 혼합합니다. 상 A 및 B를 75-80°C로 가열합니다.
2. A를 B에 넣고 손으로 잘 저어주며 A/B를 75-80°C로 유지합니다. 2000-3000 RPM, 120초로 균질화합니다.
3. 혼합하는 동안 배치를 50°C로 식힙니다. 혼합하면서 단계 C와 D의 재료를 추가합니다. 2500-3500 RPM, 120초로 균질화합니다.
4. 배치를 25°C로 식힙니다. 혼합하는 동안 상 E를 추가합니다. 2500-3500 RPM, 120초로 균질화합니다.
