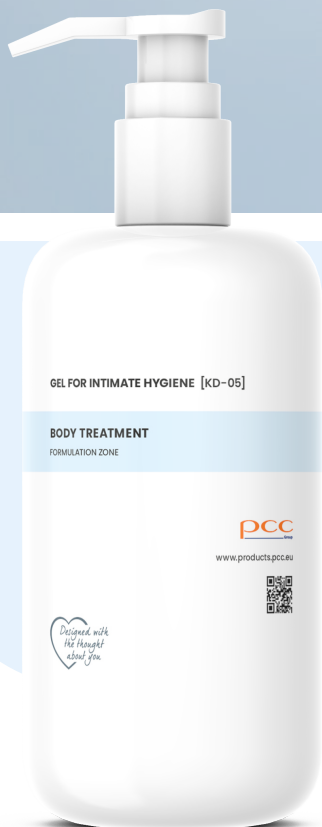

## Procedure:
