Procedure:

1. In un recipiente principale riscaldare tutti gli ingredienti a 75-80°C e fare lo stesso con la fase B.
2. Versare l'acqua calda della fase B nella fase A, mescolare bene (evitare il raffreddamento) e omogeneizzare per 5 minuti. Quindi, iniziare a raffreddare la formulazione e ripetere l'omogeneizzazione a 60°C. Procedere allo stesso modo a 40°C.
3. Contemporaneamente preparare la fase C miscelando Xanthan Gum, Glicerina e acqua tiepida (50°C). Per ottenere una soluzione omogenea, omogeneizzare per 1 min.
4. Unire gli ingredienti della fase D e mescolare fino a ottenere un composto uniforme. Se necessario, aggiungere acido citrico.
5. Aggiungere le fasi D e B al recipiente principale (fase A) e miscelare per 5 min, quindi omogeneizzare per 1 min.
