- 혼합하는 동안 상 B 재료를 추가합니다. 균일한 용액이 얻어질 때까지 저어줍니다.
- 계속 교반하면서 상 CE의 성분을 첨가한다. 균일한 농도가 될 때까지 혼합합니다.
- 젯산으로 pH를 5.0-5.5 수준으로 조정합니다.
