Procedure:

1. Dalam bekas yang berasingan gabungkan bahan-bahan dari fasa A dan B.
2. Masukkan fasa B ke fasa A semasa mengadun. Homogenkan 60-90 saat. Dalam bekas berasingan satukan bahan dari fasa C. Gaul sehingga sekata.
3. Masukkan fasa C semasa mengadun. Homogenkan dengan 2500- 3500 RPM, 45 saat.
4. Masukkan fasa D semasa mengadun. Homogenkan dengan 2500- 3000 RPM, 45 saat.
5. Masukkan bahan fasa E - F semasa mengadun. Homogenkan dengan 2500-3500 RPM, 90 saat.
