Procedure:

1. Do pomocnej nádoby pridajte homogén z fázy A a zahrejte na 80°C, miešajte, kým nevznikne homogénny roztok.

3. Do hlavnej nádoby za stáleho miešania pridajte ROSULfan LP a roztok z pomocnej nádoby.
