## Procedure:

3. Tillsätt ingredienser från fas B. Blanda tills det är enhetligt. Kyl satsen till minst 30°C.
4. Tillsätt långsamt Coco Betaine under omrörning. Blanda tills det är enhetligt.
5. Justera vid behov pH med mjölksyra till 4,0 - 4,5.
