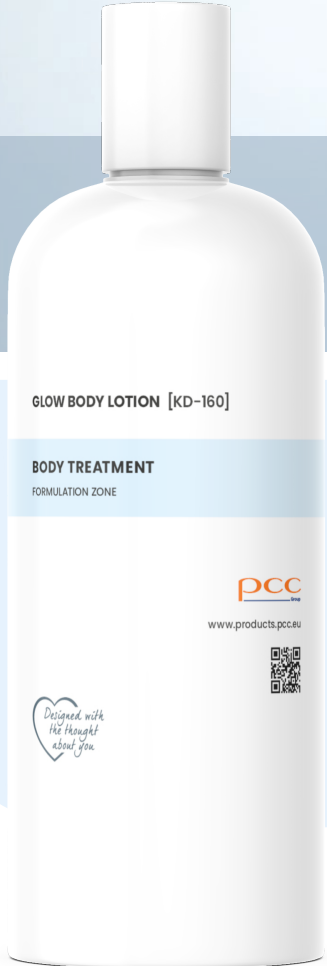

Procedure:
