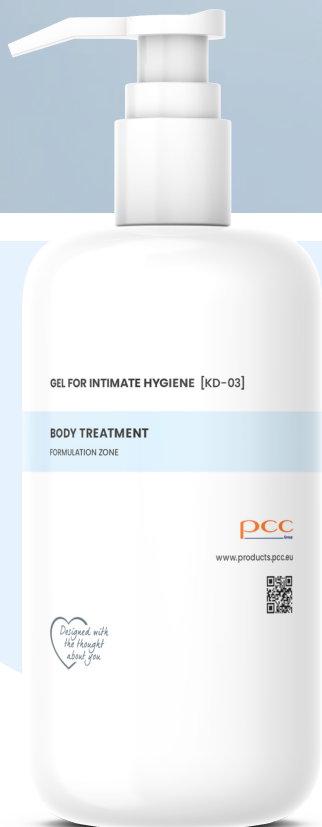

Procedure:

1. Combine los ingredientes de la fase A. Agregue los ingredientes de la fase A al agua tibia (40-45°C). Mezclar hasta obtener una solución homogénea. Enfríe el lote a por lo menos 30°C.
2. Agregue perfume mientras mezcla.
3. Agregue Coco Betaine mientras mezcla. Mezclar hasta que quede uniforme.
4. Si es necesario, ajuste el pH mediante ácido láctico a 4,0 - 4,5.
