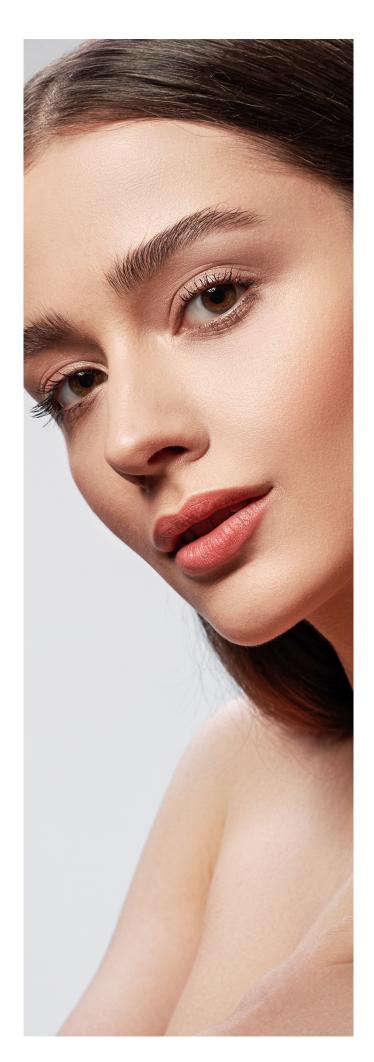

## **Procedure:**

- 주 용기에 상 A의 성분을 결합합니다. 잔탄검을 글리세 린에 첨가하고 균일한 용액이 얻어질 때까지 혼합합니다. 그런 다음 상 A의 따뜻한 물(50-55℃)을 주 용기에 붓고 혼합합니다. 방부제를 추가합니다. 2-3분 동안 균 질화합니다.
- 2. 상 B의 재료를 합치고 균일해질 때까지 혼합합니다. pH 범위를 조절합니다. 필요한 경우 구연산을 추가합니다.
- 3. A상에 B상을 넣고 잘 섞는다. 배치를 30°C로 식히고 2-3분 동안 균질화합니다.
