3. Tillsätt PEG-120 Methyl Glucose Dioleate under blandning. Blanda tills det är enhetligt. Kyl satsen till minst 30°C.
4. Tillsätt Cocamidopropyl Betaine under blandningen. Blanda tills det är enhetligt.
5. Justera det slutliga pH-värdet till 5,0 - 6,5 med ytterligare mjölksyra.
