Procédure:

- Verser l'eau chaude déminéralisée (40-50°C) dans le récipient principal et ajouter le polymère croisé Acrylates/C10-30 Alkyl Acrylate. Commencez à mélanger lorsque le polymère est complètement mouillé. Mélanger jusqu'à l'obtention d'une solution homogène.
- Combiner les ingrédients de la phase B dans un récipient séparé. Chauffer jusqu'à 30°C en agitant doucement. Mélanger jusqu'à l'obtention d'une solution homogène.
- Ajouter la phase B à la phase A. Mélanger jusqu'à l'obtention d'une solution homogène. Refroidir le lot à 30°C.
- Lorsque la température du lot est de 30°C, ajouter le conservateur, le parfum et l'hydroxyde de sodium. Mélanger pendant 20 minutes sous agitation lente.
- Réajustez le pH final à 5,0 - 6,0 en ajoutant de l'hydroxyde de sodium (30 %) si nécessaire.
