Procedure:

- Sejukkan kumpulan ke sekurang-kurangnya 35°C.
- Tambah wangian, PEG-7 Glyceryl Cocoate dan pewarna semasa mencampurkan. Gaul sehingga seragam.
- Tambah perlahan Cocamidopropyl Betaine semasa mencampurkan. Gaul sehingga seragam.
- Tambah Natrium Klorida untuk melaraskan kelikatan. CATATAN. Masukkan garam (bukan sekali gus) - selepas penambahan setiap bahagian gaul rata.
- Kawal julat pH - jika perlu, tambah asid sitrik. Gaul rata selepas pelarasan.
- Kawal kelikatan jika perlu, tambah Natrium Klorida.
