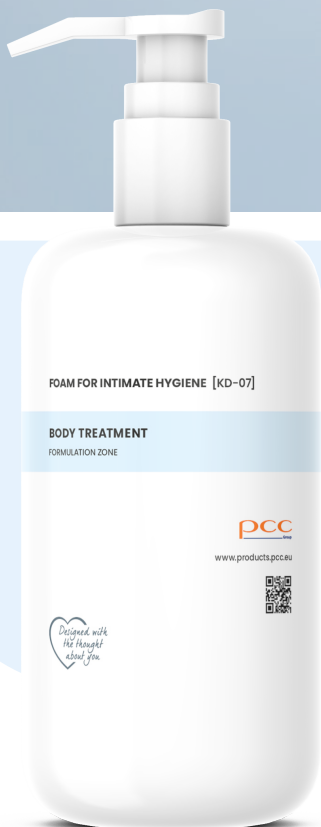

Procedure:

1. Dalam bekas utama gabungkan bahan-bahan dari fasa A. Tambah bahan-bahan dari fasa A ke air suam (40-45°C). Gaul sehingga seragam.
2. Tambah PEG-120 Methyl Glucose Dioleate dan Panthenol. Gaul sehingga seragam. Sejukkan kumpulan ke sekurang-kurangnya 30°C.
3. Tambah Cocamidopropyl Betaine dan Parfum semasa mengadun. Gaul sehingga seragam.
4. Jika perlu, laraskan pH oleh Asid Laktik kepada 4.0 - 4.5.
