## Procedure:

1. In un recipiente separato unire gli ingredienti della fase A. Aggiungere lentamente Acrylates/C10-30 Alkyl Acrylate Crosspolymer all'acqua durante la miscelazione. Mescolare fino a uniformare. Aggiungiti altri componenti della fase A.
2. Omogeneizzare con 2000-3000 RPM, 90-120 sec.
3. Aggiungere gli ingredienti della fase C durante la miscelazione. Omogeneizzare con 2000-3000 RPM, 90-120 sec.
