Procedure:

2. Resfrie o lote até pelo menos 35°C.
3. Adicione os ingredientes da Fase B enquanto mistura. Mexa até obter uma solução homogênea.
4. Sem parar de mexer, acrescente os ingredientes da fase CE. Misture até obter uma consistência uniforme.
5. Ajuste o pH com ácido láctico para um nível de 5,0-5,5.
