Procedure:

- Tillsätt citronsyra och polyquaternium-10 till varmt vatten (40-45°C) under blandningen. Blanda tills homogen lösning erhålls.
- Tillsätt ingredienser från fas A till varmt vatten (40-45°C). Tillsätt ingredienserna efter varandra under blandningen i ordningen enligt tabellen ovan. Blanda tills det är enhetligt.
- Tillsätt fas B till fas A. Blanda tills homogen lösning erhålls. Kyl ner satsen till 35°C.
- Tillsätt parfym och Cocamidopropyl Betaine under blandningen. Blanda tills homogen lösning erhålls.
- Om det behövs, tillsätt natriumklorid för att justera viskositeten.
- Kontrollera pH-intervallet – tillsätt citronsyra vid behov. Blanda väl efter justering.
