## Procedure:

1. Combineer ingrediënten uit fase A en B in aparte vaten.
2. Voeg tijdens het mixen fase B toe aan fase A. Homogeniseren 60-90 sec. Combineer de ingrediënten uit fase C in een apart vat. Meng tot een uniform mengsel.
3. Voeg fase C toe tijdens het mixen. Homogeniseren met 2500-3500 RPM, 45 sec.
4. Voeg tijdens het mixen fase D toe. Homogeniseren met 2500-3000 RPM, 45 sec.
5. Voeg fase E t/m F-ingredienten toe tijdens het mixen. Homogeniseren met 2500-3500 RPM, 90 sec.
