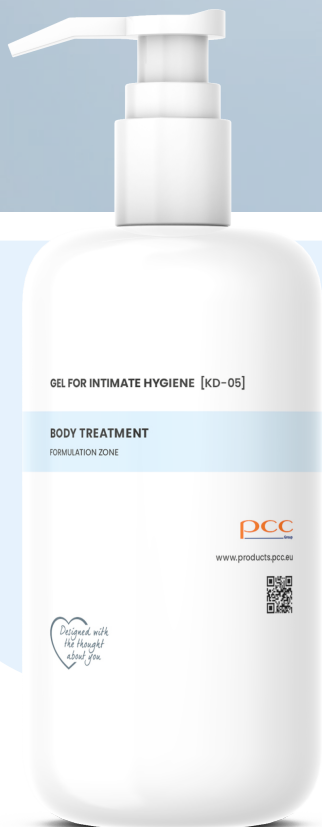

2. Násada sa ochladí aspoň na 30 °C.
3. Počas miešania pomaly pridajte Coco Betaine a Parfum. Miešajte, kým nebude jednotná.
