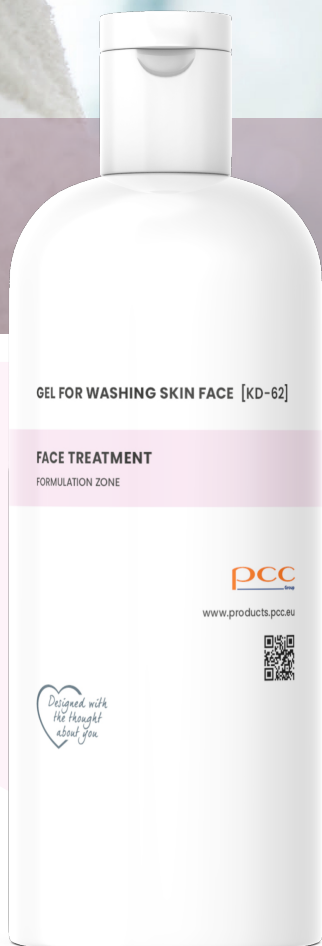

Procedure:

1. Despeje a água deionizada (25–30°C) no recipiente principal e adicione o polímero cruzado de acrilatos/alquil acrilato C10-30. Comece a misturar quando o polímero estiver completamente molhado. Misture até obter uma solução homogênea. Homogeneizar por 1-2 minutos.
2. Combine os ingredientes da fase B em um recipiente separado. Aqueça até 40–45°C com agitação suave. Misture até obter uma solução homogênea.
3. Adicione lentamente a fase B à fase A enquanto mistura. Misture até ficar uniforme.
4. Adicione Conservante, Cocamidopropyl Betaine e Parfum enquanto mistura. Misture até ficar uniforme.
